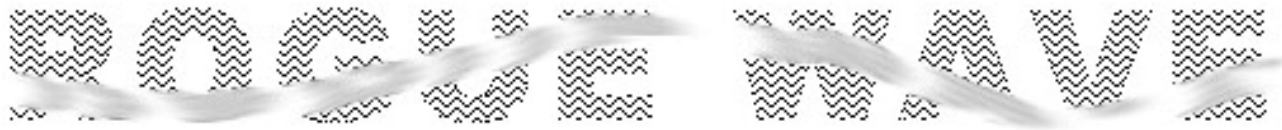

## 2010 EXHIBITION POLICY & APPLICATION

### THE ARTIST

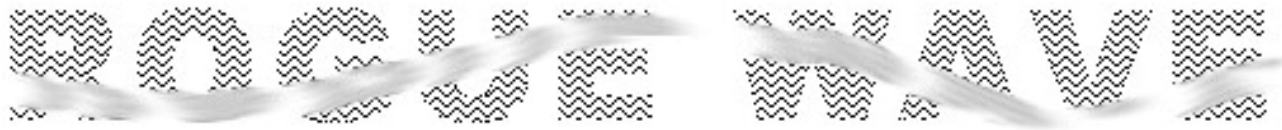
1. To confirm participation, your site location, and ensure that your installation meets criteria around safety & liability issues, artists are requested to submit proposals and this agreement by **August 1, 2010** to Joanna Kidd at [joakidd@sympatico.ca](mailto:joakidd@sympatico.ca) or by mail to Joanna Kidd, Rogue Wave 2010, 7 Oneida Avenue, Toronto, M5J 2E2. Registration fee is to be paid at that time.
2. The artist(s) will assume artistic control and responsibility of her/his work. Participants are asked to use materials and work in ways that are safe for human interaction, can endure the elements for the duration of the exhibition, and are environmentally-friendly.
3. The works of art will be exhibited from September 11 to November 6, 2010. Artists are responsible for installing their work in time for the beginning of the Rogue Wave exhibition on **September 11, 2010**.
4. Following the exhibition, the artist(s) is responsible for the removal of the work **within one week of the closing**. Participants are reminded that our liability insurance is for the duration of the exhibition only and that you are not covered should anything occur following the exhibition. Also, we have made an agreement with City Parks, Recreation and Forestry regarding the length of the exhibition that we wish to honour.

### ROGUE WAVE

1. *ROGUE WAVE* will provide liability insurance for the duration of the exhibition. This insurance covers any potential harm to individual(s) interacting with the work. It does not cover damage to art works from weather or vandalism.
2. *ROGUE WAVE* will provide promotion of the exhibition through media opportunities, posters, ads, etc.
3. *ROGUE WAVE* will provide information on the exhibition at the Ward's Island Ferry Dock including maps for visitors for the endurance of the exhibition.
4. *ROGUE WAVE* will ensure that all works are properly labeled and that a security fence is installed, if necessary.
5. The *ROGUE WAVE* Team is committed to ensuring that the exhibition is a success and participants are satisfied with their involvement. We are available to artists for assistance and consultation.
